MUNICIPAL OPERATIONS:

- Professional staff are employed in the area of budgeting and finance. http://www.frazertownship.net/offices.html.
- A revenue-expenditure trend analysis is conducted annually during budget preparation meetings. A revenue-expenditure trend analysis is conducted annually during budget preparation meetings.
- Funds for capital expenses are not used for day to day expenses.

 For the first time in Township history, Frazer Township created a Capital Reserve Fund in 2006 to set aside funds for capital-related borrowing for major improvement projects. Line items were created to save for repair of the maintenance building roof, a new backhoe, a new five-ton truck, a skid loader, road construction projects, a legal reserve, and updates to the Zoning Ordinance.
- Municipality routinely evaluates ability to ensure that revenue is sufficient to maintain public infrastructure, i.e., road, water, sewer, stormwater (community has an asset management based budget system).

In October of each calendar year, the Board of Supervisors hold a public meeting to work on the budget for the following year to evaluate financial status and to insure that revenue is sufficient to maintain public infrastructure and public safety.

- Obligations for pensions/other post-employment benefits are funded for the long-term to at least 80%. Pension obligations are an essential part of the budget and are provided for through approval of a Minimum Municipal Obligation each September and placed in the budget http://www.keystatepub.com/keystate-pdf/PA/Allegheny/Frazer%20Township/Ordinances%20Adopted%20Since%20Last%20Update.pdf.
- 5-10 percent of operating funds are carried over year to year. At least 5-10% of operating funds are carried over year to year.
- Taxation takes a balanced approach applicable to all sectors of municipal services provided and fees satisfy cost recovery.

Green vehicle fleet assessment has been initiated toward: reducing fuel consumption, using greener fuels and/or vehicles, vehicle right-sizing for the job/trip, retrofit or replace older diesel trucks or equipment with cleaner technology, or driver education about driving techniques for fuel economy.
 Green vehicle fleet assessment was evaluated and discussed at the Board of Supervisors meetings in May and June of 2012 while researching the purchase of new police vehicles. The Board agreed with the Chief of Police that choice of newer green model vehicles was limited and would not meet the current needs of the Township.

COMMUNITY ENGAGEMENT:

Civic engagement, public participation and transparency are regularly assessed and facilitated.

Community engagement and public participation are encouraged through public comment at Board of Supervisors meetings or by e-mailing the Township Secretary at frazertwp@comcast.net.

A Historic Review Commission is active.

The Township Secretary continually requests historical information and photographs from the public that may be viewed in the Trivia section of the Township's website www.frazertownship.net.

• Municipality communicates with the public via a regularly scheduled newsletter or regularly updated web based communications.

The Township's website also has reference to a quarterly newsletter that may be found on the home page under General Information (http://www.frazertownship.net/TownshipsToday.pdf).

- All municipal-sponsored events have a sustainability-awareness component Annual Clean-Up Days are held each May and dumpsters are provided for use by residents at the Township's Maintenance Building. Information is posted each April on the scrolling marquis on the Township website www.frazertownship.net.
- A program exists to actively pursue and match residents and local businesses to volunteer opportunities to better the community and assist the local government.

The Township actively pursues residents to volunteer for various positions that are listed in the Announcements section of the Township website (http://www.frazertownship.net/announcement.html).

LOCAL AND REGIONAL COOPERATION:

- Municipality is an active participant in a Council of Governments. Frazer Township is an active participant in the Allegheny Valley North Council of Governments.
- The municipality utilizes Intergovernmental Cooperative Agreements (ICA) to engage in multimunicipal endeavors.

The Township routinely works with our municipal neighbors and school district and utilizes Intergovernmental Cooperative Agreements to engage in multi-municipal endeavors. Past examples include a Multi-Municipal Comprehensive Plan with East Deer and Springdale Townships in 2002, a Police Services Agreement with Tarentum Borough in 2005, a Cost-Sharing Agreement with the Deer Lakes School District in 2007, and an agreement with East Deer Township in 2008 to attempt to form a regional police department.

• Intergovernmental Cooperative Agreements include conflict resolution provisions. All such agreements, upon the advice of legal counsel, include conflict resolution provisions. **Ordinance No. 134** authorized the Township to enter into a police services agreement with Tarentum Borough. http://www.keystatepub.com/keystate-pdf//PA/Allegheny/Frazer%20Township/Appendix.pdf

- A sustainability assessment has been conducted to evaluate municipal facilities, operations, plans and
 regulations relative to conserving resources, saving money, and implementing policies and procedures
 that simultaneously advance the environment, economy, and social equity.

On March 1, 2012, the Township participated in the Allegheny County Energy Program for Municipalities (ACEPM) to assess municipal facilities for energy conservation. Improvements completed included replacement of lighting, thermostat, hot water heater, and toilets so that the maintenance building is more energy efficient. A check was received from West Penn Power in the amount of \$389.89 to help offset the cost. (http://www.keystatepub.com/keystate-pdf/PA/Allegheny/Frazer%20Township/Appendix.pdf).

- There is on-going training for municipal employees and officials and the HR function is closely engaged in advancing objectives of the municipal sustainability program.
- Procedures are in place to measure and track the impacts of the sustainability program (and yearly reporting to the public on results is conducted).
- An executive/management level municipal staff person has responsibility for management of the municipal sustainability program expressly included in their job description.
 In November, 2013, the Township Secretary's job description was updated to include responsibility for
- management of the municipal sustainability program
 - Professional development for municipal personnel and officials includes participating (at a minimum, per year) in quarterly Local Government Academy, PA DCED or other professional training association programs.
 - Newly elected officials participate in Local Government Academy or other orientation training for public officials.

PUBLIC SAFETY

 Municipality maintains updated public safety mutual aid agreements with neighboring municipalities and shares resources.

Frazer Township maintains written Mutual Aid Agreements with Indiana Township, West Deer Township, Springdale Borough, Fawn Township, Springdale Township, Brackenridge Borough, Harmar Township, Blawnox Borough, East Deer Township and Harrison Township. Police and Fire personnel

 Municipality maintains an updated Public Safety comprehensive plan to be sure staffing and financial resources keep pace with municipal needs for Police, Fire, and Emergency Medical Services.

In 2002, Frazer Township entered in to a Tax Increment Financing Plan with Pittsburgh Mills and the Redevelopment Authority of Allegheny that includes an annual Public Safety payment to the Township to support the cost of public services resulting from the development of the Pittsburgh Mills mall and shopping complex (http://www.keystatepub.com/keystate-pdf/PA/Allegheny/Frazer%20Township/Appendix.pdf) – **Resolution 2002-3.**

• Municipality participates in a regional service program or contracts services to or through other municipalities for fire, police, or EMS.

Prior to the development of Pittsburgh Mills, Frazer Township relied on State Police and did not have the Frazer Township Police Department. In order to insure public safety once the mall was built, Frazer contracted police services from neighboring Tarentum Borough before forming the Frazer Township Police Department in 2008 – **Ordinance No. 134** (http://www.keystatepub.com/keystate-pdf/PA/Allegheny/Frazer%20Township/Appendix.pdf) **page A-12**

LOCAL FOOD

- Incentives exist for establishment of farms and gardens within the municipality. Frazer Township values its rural farms and in 2001 formed an Agricultural Security area to protect local farms from imminent domain (http://www.keystatepub.com/keystate-pdf/PA/Allegheny/Frazer%20Township/Appendix.pdf) page A-10.
 - The municipality supports a program (or cooperates with neighboring communities) to engage residents in strengthening sustainable food systems to link local foods, farms and people (ex. Buy Fresh Buy Local initiative, Good Food Neighborhood, etc.).
 - Education programs are made available for residents on the benefits of organic, locally-purchased food; farmers' markets and farm stands are facilitated.

In 2006, in conjunction with Pittsburgh Mills, the Frazer Township Farmer's Market was formed in an effort to marry the rural and commercial aspects of the Township. Several resident farmers participate in the Farmer's Market at Pittsburgh Mills. Information can be found on the Township's website (http://www.frazertownship.net/) in the scrolling marquis.

• A community produce garden(s) is available.

HEALTHY PEOPLE

• Programs by local government, or in cooperation with the non-profit and private sector, exist to address community health concerns, i.e. exercise programs, feeding programs for children and the elderly, crime watches, accessible health care, exercise away from areas of air pollution, etc.

A local business. Destination Wellness

(http://triblive.com/x/valleynewsdispatch/living/s_643286.html#axzz37SwM9DnU) regularly hosts public educational programs related to healthy lifestyles.

Destination Wellness (https://www.ahn.org/locations/allegheny-valley-hospital/mills-milers-mall-walkers) also hosts the Mall Walkers program and health related seminars.

- Outdoor recreation opportunities, amenities, and lifestyles are promoted.

 Outdoor recreation is promoted and supported in Deer Lakes Park and the Wagman Observatory (www.3ap.org). Information may be obtained from the Township's website under Places of Interest.
 - A program to promote safe walking to school is in place.
 - The use of pesticides and herbicides is being monitored and reduced by all municipal departments which use them.

The Township road department minimally utilizes pesticides to control weed growth along Township roads. Most weed control is managed by hiring an independent contractor with a boom mower to cut weeds along the roads.

HUMAN RESOURCES

• Measures are taken to ensure a wide range of candidates are interviewed for all municipal job openings i.e., the Rooney Rule.

Most personnel turnover is in the Township's police department. Interested applicants may download the application from the Township's website. It can be found on the website's home page under Police Department (http://www.frazertownship.net/PoliceApplication.pdf).

• The municipality has a written municipal policy prohibiting discrimination and valuing diversity and inclusion.

- The municipality has provided diversity training for municipal employees. The Police Department routinely provides non-discrimination training to all officers.
 - The municipality annually assesses, and reports to the public, diversity of all boards, employees, volunteers, committees, etc.
 - The municipality reports annually to the public on progress in creating a more diverse workforce

ECONOMY

• There is a municipal policy ensuring Minority Business Enterprise and Women Business Enterprise are considered in municipal purchasing, bids and contracts.

Frazer Township regularly participates with the Allegheny Valley North Council of Governments and the SHACOG purchasing alliance in advertising for bids for road improvements, rock salt, and Spring and Fall commodities (www.shacog.com).

• The municipality is engaged in programs to communicate that the community is welcoming to persons who represent diversity (sister city relations, diversity sensitivity training, multilingual signage, etc.)

COOPERATION

 Municipal planning is coordinated with the school district and the two meet together at least once per year.

Joint annual meetings take place with the Deer Lakes School District, West Deer Township and East Deer Township.

• The municipality and local public schools cooperate to share facilities, vehicles, and/or other resources. (For example, the municipality assists with the cost of evening lifeguards for community use of a school swimming pool or for provision of crossing guards).

ENGAGEMENT

• Municipality works with schools and local nonprofits/community organizations to engage students about community issues such as waste reduction and recycling, public safety, wellness, conservation, nature, etc.

Frazer Township regularly works with our local ITT Technical Institute educational seminars for the Criminology majors. The Chief of Police meets with students and provides insight on the workings of a local police department (http://www.itt-tech.edu/campus/school.cfm?lloc_num=89).

MUNICIPAL ENERGY USE

 The municipality has recently completed an energy audit of all municipal buildings and operations. The audit includes findings and recommendations and establishes a baseline of energy usage.

On March 1, 2012, the Township participated in the Allegheny County Energy Program for Municipalities (ACEPM) to assess municipal facilities for energy conservation. Improvements completed include replacement of lighting fixtures and bulbs, thermostat, hot water heater, and toilets (http://www.keystatepub.com/keystate-pdf//PA/Allegheny/Frazer%20Township/Appendix.pdf) page A-12.3

• The municipality has established goals from the energy audit findings and is methodically implementing the energy audit findings.

The Township is currently acquiring prices for replacement of man doors, garage doors, and furnace to complete the energy conservation improvements at its maintenance building http://www.keystatepub.com/keystate-pdf//PA/Allegheny/Frazer%20Township/Appendix.pdf page A-12.2

- Municipal energy use has declined overall at least 15% from the baseline year established in the energy audit.
- Municipality is reporting yearly to the public on progress and results made in implementing recommendations/findings contained in the municipal energy study.
- Municipality is managing outdoor lighting for conservation (and light pollution) and has or is in the process of retrofitting street lights and traffic signals to LED bulbs.
- As part of the energy audit, a greenhouse gas inventory and mitigation plan has been established for municipal functions.

- Positive progress on the greenhouse gas inventory and mitigation plan is reported annually to the public.
- Energy performance of key municipal buildings is tracked using ENERGY STAR Portfolio Manager and is reported yearly to the public.

COMMUNITY ENERGY USE

- The municipal comprehensive plan contains an energy conservation element.
- Municipal support is provided to a public program (throughout the community and for businesses) to conserve energy, promote renewable energy sources, and mitigate carbon emissions.

The Fawn-Frazer Water Authority (water) and the Frazer Township Authority (sewer) charge rates based on the real cost of providing services. In fact the Frazer Township Authority has a written Sewer Agreement with the Upper Allegheny Joint Sanitary Authority and Pittsburgh Mills Limited Partnership that limits the amount the Frazer Township Authority may add to any sewer bill in connection with preparation and collection the sewer bills to 15% of an individual sewer bill (http://www.keystatepub.com/keystate-pdf//PA/Allegheny/Frazer%20Township/Appendix.pdf) -page A-17.
 - Sufficient investments are being made to the water, sewer, and stormwater systems per real costs and keeping pace with maintenance and operations.

The Frazer Township Authority has signed a Maintenance Agreement with Pittsburgh Mills whereby all costs for sewer line maintenance are the responsibility of Pittsburgh Mills. http://www.keystatepub.com/keystate-pdf//PA/Allegheny/Frazer%20Township/Appendix.pdf, Appendix F.

• Cooperation is occurring with neighboring municipalities to manage water and sewer supply, treatment and distribution, sewage and stormwater, in the most cost-efficient way.

The Frazer Township Authority is an active participant with Upper Allegheny Joint Sanitary Authority (www.uajsa.com/page3.htm.uajsa.com) and its member communities. Recently, joint meetings have taken to place to address an EPA Consent Decree for replacement or repair of sewer lines.

AIR QUALITY

- PA State anti-idling law is enforced and compliance is promoted.

- Municipality supports public education regarding reducing air pollution and emissions. Frazer Township supports public education regarding reducing air pollution and emissions and encourages enforcement of the law (http://www.reenergizepgh.org/Program)
 - A clean construction emissions policy for all publically subsidized projects has been adopted and is enforced.
 - A burn ban has been formally adopted and made part of municipal ordinance, and State or County outdoor wood fired boiler construction and operation is in accordance with state law.

Open burning is prohibited by Allegheny County Health Department and the Township frequently calls Health Department officials to enforce the prohibition of open burning (http://www.alleghenycounty.us/emerserv/firemar/openburn.aspx).

• The municipality and its municipal waste hauler service are exploring ways to reduce emissions from vehicles and trucks beyond anti-idling.

GREEN INFRASTRUCTURE

- Policies, plans and ordinances protect wetlands and waterways and their buffers.  - Written policies exist and ordinances and incentives have been enacted to conserve

 soils and geology, springs and vernal pools, mature woodlands, Natural Heritage Areas, etc.) in
 order to protect public safety and natural resources while using green infrastructure for
 stormwater management.

- Tree and woodlands protection and management policies are in place (for example, community
 forestry plan and canopy goal; tree planting programs; tree maintenance programs; tree hazard
 and health assessment projects; computerized assessment of municipal trees, Tree/woodland
 replacement criteria in ordinances, etc.).
- A natural resource inventory has been developed for the community within the last 7 years as part of the comprehensive plan.
